NEWSLETTER SERVICE POLICY

pursuant to article 13 of Reg. (EU) 2016/679
on data protection.

Aristoncavi Spa, with registered office in Via L. Einaudi, 8, 36040 Brendola VI in its capacity as Data Controller (henceforth the "Company" or "Controller"), in accordance with the provisions of Reg. (EU) 2016/679 (hereinafter Regulation) and current legislation on the protection of personal data, hereby informs you that it carries out processing activities of data concerning you, in order to provide the "Newsletter" service containing commercial and business information.

The personal data that concern you, provided directly by you, is acquired and processed in compliance with the above mentioned regulation, with the support of paper, computer or telematic means to store, process, manage and transmit such data and, in any case, by means of tools suitable to ensure its security and confidentiality, in compliance with the rules established by the regulation, for the following purpose:

- *Subscription to and registration for the Newsletter service for those who request it by entering their e-mail address in the appropriate online form.*

The processing is carried out in accordance with article 6(1)(a) of the Regulation and therefore requires your explicit consent. The provision of data for this purpose is optional, but refusal to provide it, in whole or in part, may make it impossible for the undersigned to provide the requested service.

Without prejudice to the communications carried out in fulfilment of legal obligations, the data collected and processed may be communicated, for the purposes mentioned above, to parties that operate as Data Controllers such as, for example, authorities or control and supervisory bodies which are allowed to request the data. The data may also be disclosed to processors acting on behalf of the undersigned, in accordance with article 28 of the Regulation, such as, for example, companies appointed to provide management services and technological maintenance of the website and persons authorised to processing trained on the management of personal data processing in accordance with article 29 of the Regulation, which will process it in accordance with this policy. Processing is not subject to automated decision-making processes, including profiling. The data will not be disseminated.

The data will be processed by the undersigned until you decide to unsubscribe from the Newsletter service. In this regard, we hereby inform you that you can unsubscribe by clicking the "unsubscribe" button at the bottom of the e-mails received, as well as exercise withdrawal of consent by sending an email to privacy@aristoncavi.com.

If you have requested deletion from the service, we hereby inform you that the undersigned will take reasonable steps to securely delete such data or to render it anonymous, thus permanently unidentifiable.

In relation to data processing, in accordance with the provisions of Chapter III of the Regulation, data subjects have the right to request the Data Controller for access to personal data, its rectification, integration or erasure, restriction of processing concerning them, object to processing, withdraw consent and lodge a complaint with a supervisory authority. According to the right to portability, in the event that the processing is based on a contract or consent and is carried out by automated means, data subjects have the right to receive the data in a structured, commonly used and machine-readable format, as well as the right to transmit it to another controller without hindrance, if technically feasible.
